

She has spoken at conferences including National Online Meeting, Computers In Libraries, and NYLA, and has served on the board of the SMART Section of NYLA and the Program Committee of Computers In Libraries. This session will provide a panoramic overview of the choices faced in purchasing ebooks by the modern academic library, with some concrete examples of what the Syracuse University Library has already done and what they're considering.

Scott Warren has been Head of Collections at the Syracuse University Library since January 1, 2011. He is involved in collections budget analysis and allocation, developing collections policies and procedures, reviewing and managing electronic resources licenses, and a variety of other collections-related duties. Scott came to Syracuse in 2008 as Bibliographer for the Sciences and Technology and continues in the role.

Scott received his MA in Library and Information Studies from the University of Wisconsin-Madison, and bachelor's degrees in mathematics, physics, astronomy, and history from the Pennsylvania State University. Prior to joining the SU Library Scott served as a Library Fellow (2001-2002), Librarian for the Physical and Mathematical Sciences (2002-2004) and Associate Director of the Textiles Library and Engineering Services (2004-2008) at North Carolina State University libraries. For the more than twenty years digital content has been proliferating through the library community at an ever increasing pace. Every day the amount of digital content increases empirically providing an ever increasing number of choices to the library and the publisher. At times making printed publications obsolete and many times no longer available. Learn how this evolution to digital content has changed and shaped a small specialty legal publisher over those twenty-some years. From the advent of CD-ROMS in the late 80's and early 90's to massive online content repositories available today.

Daniel P. Rosati is Senior Vice President of Technology at William S. Hein & Co., Inc. Dan has worked at the Hein company for the past 30 years mostly in the areas of technology and service & product development. He was one of the original architects of HeinOnline, Hein's premier online product. Dan holds a Bachelor of Science degree in Information Systems from the State University of New York College at Buffalo.
