- “Privacy Law - Where Are We Now?”

At the 2012 Spring Institute, Andrew gave a presentation about the history of privacy law in the United States. He attempted to outline major developments in privacy law in relation to the government and in relation to commerce (private interests), tracing them from colonial times through the (then) present day. Just three years later, much more has become known about certain aspects of privacy law. Edward Snowden's leak of NSA practices, and subsequent government defenses of those practices, have raised many legal questions that have yet to be answered. This presentation will attempt to identify those questions and the current state of law with regard to them. The current state of "non-NSA" privacy law developments will also be discussed, including local law enforcement and commercial practices. As was the case three years ago, much is still undecided.

**North** - Interstate 81 south to exit 18. Get in center lane and continue on to Adams Street. Make a left onto Adams Street and proceed to Irving Avenue. Make a right onto Irving Avenue and proceed to Van Buren Street. Make a right onto Van Buren Street and proceed to Henry Street. Make a left onto Henry Street and proceed to Raynor Avenue. Make a left onto Raynor Avenue and proceed to Stadium Place. Make a left onto Stadium Place and enter the first garage on your right.

**South** - Interstate 81 north to exit 18. Merge into the right hand lane and continue on to Adams Street. Make a right onto Adams Street and proceed to Irving Avenue. Make a right onto Irving Avenue and proceed to Van Buren Street. Make a right onto Van Buren Street and proceed to Henry Street. Make a left onto Henry Street and proceed to Raynor Avenue. Make a left onto Raynor Avenue and proceed to Stadium Place. Make a left onto Stadium Place and enter the first garage on your right.

**East** - Interstate 90 to exit 36 Interstate 81 South. Take Interstate 81 South to exit 18. Get in center lane and continue on to Adams Street. Make a left onto Adams Street and proceed to Irving Avenue. Make a right onto Irving Avenue and proceed to Van Buren Street. Make a right onto Van Buren Street and proceed to Henry Street. Make a left onto Henry Street proceed to Raynor Avenue. Make a left onto Raynor Avenue and proceed to Stadium Place. Make a left onto Stadium Place and enter the first garage on your right. From Interstate 690 west to exit 13 Townsend Street. Turn left on South Townsend Street to Adams Street. Make a left onto Adams Street, and proceed under Interstate 81 to Irving Avenue. Make a right onto Irving Avenue and proceed to Van Buren Street. Make a right onto Van Buren Street and proceed to Henry Street. Make a left onto Henry Street proceed to Raynor Avenue. Make a left onto Raynor Avenue and proceed to Stadium Place. Make a left onto Stadium Place and enter the first garage on your right.

**West** - Interstate 90 or Interstate 690 to Interstate 81 south to exit 18. Get in center lane and continue on to Adams Street. Make a left onto Adams Street and proceed to Irving Avenue. Make a right onto Irving Avenue and proceed to Van Buren Street. Make a right onto Van Buren Street and proceed to Henry Street. Make a left onto Henry Street and proceed to Raynor Avenue. Make a left onto Raynor Avenue and proceed to Stadium Place. Make a left onto Stadium place and enter the first garage on your right.
