	Consensus, the Commission on Local Government, was created in 2014. Its goal is to shape a vision for more effective and efficient governance across Onondaga County. After years of development and 18 months of citizen-led review and discussion, the City of Syracuse and Onondaga County stand at the forefront of communities across New York State and around the country in considering a merger of their governments.
	The release of the <u>Preliminary Options Report</u> on January 26 marked the beginning of a robust public comment period which will conclude on May 1. Based on public feedback received during this time, the Commission will issue a final report to the community.

	Ms. Murphy and her colleagues will lead a discussion of the opportunities and barriers presented by the possibility of a merger, as well as the implications for the rest of New York State.
