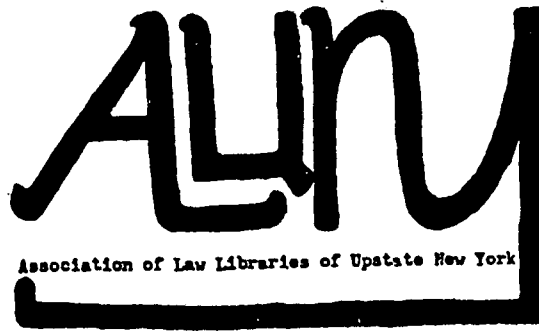

### LIMITATIONS

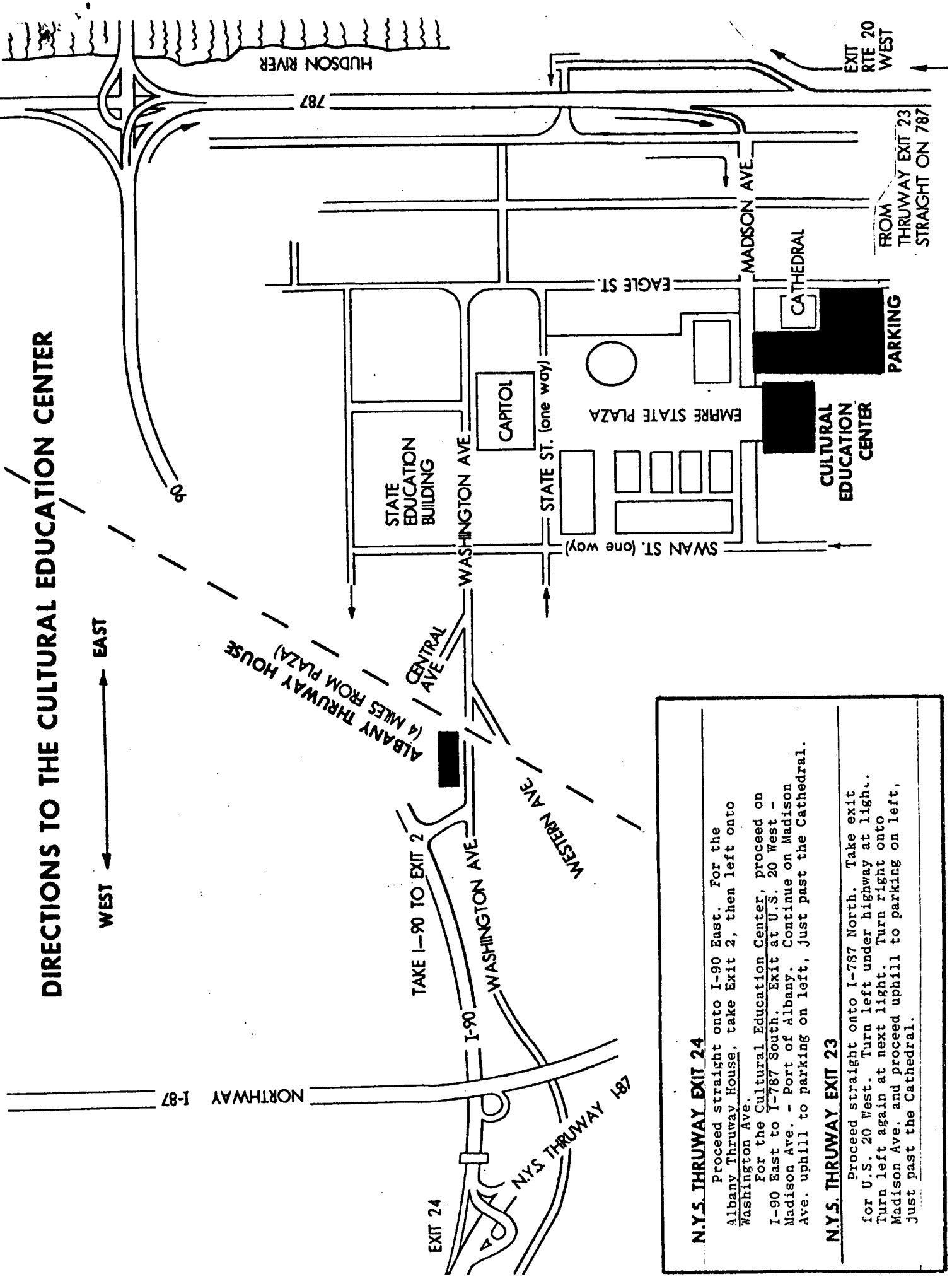
1. Any award resulting from this application will be made in an amount and in numbers to be determined annually by the Board of Directors of ALLUNY.

# DIRECTIONS TO THE CULTURAL EDUCATION CENTER



**N.Y.S. THRUWAY EXIT 24**  
 Proceed straight onto I-90 East. For the Albany Thruway House, take Exit 2, then left onto Washington Ave.  
 For the Cultural Education Center, proceed on I-90 East to I-787 South. Exit at U.S. 20 West - Madison Ave. - Port of Albany. Continue on Madison Ave. uphill to parking on left, just past the Cathedral.

**N.Y.S. THRUWAY EXIT 23**  
 Proceed straight onto I-787 North. Take exit for U.S. 20 West. Turn left under highway at light. Turn left again at next light. Turn right onto Madison Ave. and proceed uphill to parking on left, just past the Cathedral.
