Friday evening we will have a private wine and cheese party followed by a Candlelight Tour of the Benjamin Patterson Inn. This is an authentic example of a frontier inn, restored and furnished to interpret its original use, and is listed in the National Register of Historic Places.

The program covers substantive law issues of medical malpractice costs in New York State, and the new changes in New York evidence; general interest topics such as administrative opinions in New York State and Women in the Courts; and even "things they never taught you in school" !

off Routes 15 & 417.

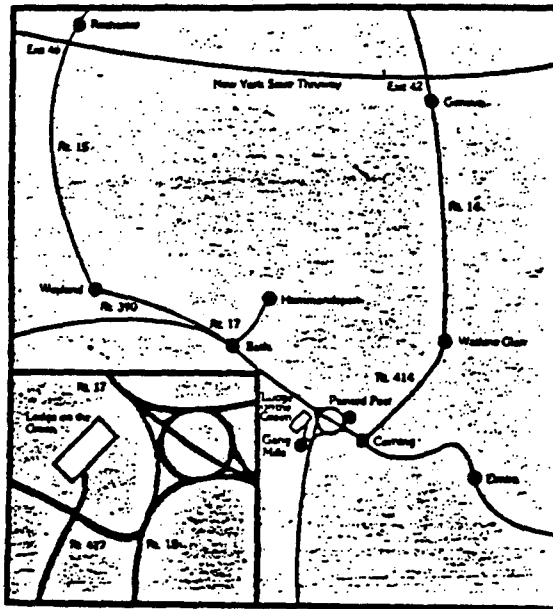
If you are coming from:

Jamestown: take Route 17 east and exit at routes 15 and 417.

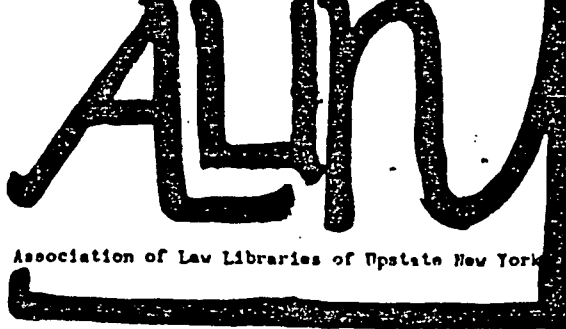
Binghamton: take Route 17 west and exit at routes 15 and 417.

3. The grant will be repaid to ALLUNY if it cannot be spent as stipulated above or, if for reasons of personal disability, you cannot attend the meeting for which the grant is made. The grant is not cumulative or transferable.
4. Successful applicants for this annual grant will be chosen by lottery on August 19, 1985. A successful applicant will not be awarded a grant in two consecutive years.

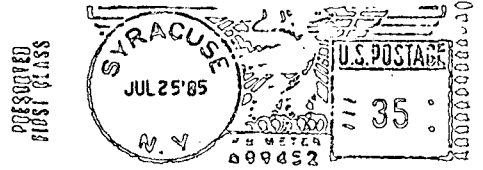
